Prerequisites

- FIN 302 is the prerequisite for FIN 361.
- ACC 340, FIN 331, and FIN 303 or FIN 361 are prerequisites to FIN 421 and FIN 461. FIN 421 is also pre- or corequisite to FIN 461.
- FIN 303 fulfills both FIN 302 and FIN 361. Barrett Honors students completing FIN 303 will need to complete an additional Finance major elective course to replace FIN 361. FIN 493 can be used as one of the Finance major elective options for students with FIN 303 credit.

Important Information

- Students must receive grades of "C" (2.00) or higher in upper-division courses for the major. If a student receives a grade below "C" in any course in the major, this course must be repeated before taking any further courses for which this course is a prerequisite. If a second grade below "C" is received in either an upper-division course in the major already taken or in a different upper-division course in the major, the student is no longer eligible to take upper-division courses in the major.
- REA 380, REA 4XX, FIN 380, FIN 484, FIN 493, and CIS 308 Advanced Excel in Business **CANNOT** be used in the major to meet the Finance major elective requirement.
- If admitted as an ACC/FIN concurrent major, ACC 340 cannot be shared and is counted toward the accountancy major and not the finance major. Also, neither ACC 350 nor ACC 440 may be used as finance major electives. You must complete 21 hours of FIN coursework in the major. You will complete 6 credits of Finance major electives that do not include ACC courses.
- The following courses must be taken from Department of Finance faculty at ASU's Tempe campus: FIN 302, FIN 361, FIN 421, and FIN 461.
